ABOUT THE MEMBERS NET TOUR...

The 2010 Members Net Tour is a series of one-day events for **all** individual member golfers of the IGA. These competitions are Net events utilizing the GHIN® Handicap Service and are collectively referred to as **The Members Net Tour**.

Entry into a Members Net Tour event is handled like every other event conducted by the IGA. You can go to www.igamembersnettour.org and sign up with a credit card or fill out this entry application and, along with a check for the entry fee, send in via standard mail. The entry fee will cover green fees, range balls (when available) lunch and prizes. Entries will be limited to IGA members. Not sure if you qualify? If you have an active GHIN® number, then you are a member of the Iowa Golf Association.

The 2010 schedule offers three “back-to-back” one-day events. That’s two competitions in one trip! The 2010 season schedule includes a mix of Individual Stroke Play and Four-Ball Stroke Play. Our goal for the Members Net Tour is to encourage golfers of various abilities to compete in IGA conducted events. Start setting your schedule today!

ELIGIBILITY: Male and female applicants must be an active member of an IGA Member Club with a handicap provided through the IGA/GHIN® Handicap Service. Members of the IGA who reside in Illinois are eligible to compete.

HANDICAP INDEX® REQUIREMENTS: Your Handicap Index® must be provided through the IGA/GHIN® Handicap Service and must include a minimum of ten (10) scores posted within the previous twelve (12) months. The handicap Index® from revision #7 (July 7th) will be used for this competition.

Rule 6-2b Handicap Stroke Play: In any round of a handicap competition, the competitor must ensure that his handicap is recorded on his scorecard before it is returned to the committee. If no handicap is recorded on his scorecard before it is returned (Rule 6-6b), or if the recorded handicap is higher than that to which he is entitled and this affects the number of strokes received, he is disqualified from the handicap competition; otherwise, the score stands.

PAIRINGS/TEE TIMES: Entry confirmation & pairings will be emailed **after** the entry deadline to those who provide an email address. Pairings will also be made available at www.igamembersnettour.org. This event is a 12:00 p.m. shotgun.

FORMAT: 18 holes of Four-Ball Stroke Play. As per the USGA Handicap System, men will receive 90% and women will receive 95% of their respective course handicaps. All teams will compete in the same division. Stableford Scoring (Rule 32) will be used to determine winner:

- a. Net Double Bogey or worse.....0 points
- b. Net Bogey..... 1 point
- c. Net Par.....2 points
- d. Net Birdie.....3 points
- e. Net Eagle.....4 points
- f. Net Double Eagle..... 5 points
- g. Net Four Strokes under Par.....6 points

The winner is the team who scores the highest number of points.

TEES: Male-male teams play from the men’s tee. Male-female teams play from separate tees (i.e. women play women’s tee and men play from the men’s tee.)

ENTRIES — FORM, FEE, CLOSING DATE:

Entrants are solely responsible for securing and returning entry forms and fees by the due date. Entries must reach the IGA office by 11:59 P.M., July 15th and must be accompanied by the appropriate fee (\$90 per team). You may enter online using a credit card at

www.igamembersnettour.org up to the deadline or until the **field limit of 48** teams is met. The entry deadline is to secure starting positions on the golf course. Late entries will only be accepted at the discretion of the IGA on the basis of available spots!

MEMBERS NET TOUR POINT LIST: All teams who return a scorecard will receive points toward the season long cumulative Members Net Tour Point List. In the Four-Ball format, points are awarded to each player based on the team finish. For example, on the 1st place team, Player A receives 400 points and Player B receives 400 points. The MNT Point System and List is published at www.igamembersnettour.org. Invitations to the MNT Tour Championship on Sept. 26 & 27 at the Tournament Club of Iowa will be distributed based on the Point List Standings after the MNT Event at The Harvester on August 31, 2010.

CONDITIONS, SCHEDULES: The IGA reserves the right to alter any of the conditions and schedules herein as needed. This may include, but is not limited to, suspending play to a following day, or cancelling current or future rounds. The decision of the Championship Committee in any matter shall be final. All possible attempts will be made to complete the event as scheduled.

WITHDRAWALS & REFUNDS: Entry fees will be refunded if the IGA office is notified on or before July 15, 2010. After July 15 fees will be refunded only in event of injury or illness. There is a \$20.00 service charge per team on all refunds.

PERSONAL APPEARANCE: Proper golf attire is mandatory; the committee reserves the right to determine whether this requirement is met. Competitors may be required to change clothing in order to compete. Shorts are permitted, provided they are Bermuda length or longer. T-shirts, tank tops, gym shorts, sweatpants and blue jeans are NOT permitted.

RULES OF GOLF: Play will be governed by the 2010-11 USGA Rules of Golf. Local rules on scorecards do not apply. Decisions concerning the rules will be settled by the Rules Committee assigned by the IGA and those decisions will be final.
